International Master of Public Administration (IMPA) Program at School of Government (2022 Entry)

Founded in 1898, Peking University was the first national university in China to offer academic training in a wide range of disciplines. Peking University has a long history and rich cultural heritage. For more than 100 years, Peking University, as one of the top universities in China, has held fast to the educational philosophies of freedom of thought and inclusiveness. It aims to nurture graduates who have international perspective, are familiar with China, and who possess foresight, introspection and innovation. In this program, students will master professional knowledge in the fields of public administration and public policy through advanced analytical methods and technology. They will be equipped with the ability to analyze and solve public sector problems in complex environments, and be well-positioned for high-level, inter-disciplinary leadership positions in the public sector.

The Peking University School of Government welcomes international students to study in the International Master of Public Administration (IMPA) program. The IMPA program seeks to enroll: university graduates interested in public sector management, government officials, staff of multinational corporations, staff of international organizations, staff of research institutions and international nonprofit organizations, as well as management staff of foreign government agencies, multinational enterprises, international organizations and nonprofit organizations based in China.

Program Mode and Registration Period

- 1) Full-time education;
- 2) 2-year program;
- 3) The language of instruction is English.

Application Requirements

- 1) Applicants must be non-Chinese citizens with a valid passport, with no criminal records, healthy both physically and psychologically, friendly to China and abiding by the laws and decrees of China. Residents of mainland China, Hong Kong, Macau or Taiwan who have emigrated to other countries and are applying to Peking University as international students must present valid passport or citizenship documents dating from before April 30, 2016, along with proof of cancellation of Chinese nationality.;
- 2) Applicants for **Master's program** must have attained a bachelor's degree and students who graduated from non-Chinese universities must hold a bachelor's degree from a university accredited by the Ministry of Education of China (Grade skipping or joining in the middle of the course is not acceptable);
- 3) Applicants must be proficient in English. Non-native English speakers or candidates whose undergraduate course was not conducted in English are required to submit a TOEFL, GRE or IELTS test score as proof of English proficiency.
- 4) All applicants shall be in good physical condition and carry no infectious diseases which may potentially have a serious impact on public health, or which fall under any of the health situations prohibited by China's Entry-Exit Inspection and Quarantine Laws and Regulations.

Application Period and Mailing Address

The application period for the IMPA program is up to March 31, 2022. Application Fee

There is a non-refundable application fee of 800 RMB. International applicants are required to use the online payment while applying through the PKU online application system.

Initial Round of Selection

The eligibility of all the applicants will be assessed according to the requirements by the Admissions Committee of School of Government. The school will select qualified applicants for an interview by the end of April, 2022.

Interview

After an initial round of selection, an interview is required before students are admitted. The

Admissions Committee will give a comprehensive test for applicants and submit the admission list to Office for External Affairs & Scientific Research.

Admission

After all examination processes and confirmation of the admission list by the Graduate School and International Students Office, the offer letter will be sent out in late June 2022 together with other necessary documents for visa processing.

Registration

Registration will take place in early September 2022. The exact date will be specified in the admission letter.

Tuition and Scholarship

- The tuition of the IMPA program will be 80,000 RMB per year, and 160,000 RMB in total for two years.
- 2) International students can apply for the following scholarships:
- (1) Chinese Government Scholarship (Type B): tuition waiver, for-free accommodation, monthly living expenses and medical insurance provided in accordance with the regulations.
 - (2) Beijing Government Scholarship for International Students: tuition subsidy.
- (3) Peking University Scholarship for International Students: tuition waiver, monthly living expenses, medical insurance.

Note: The evaluation of scholarships will be carried out in accordance with the relevant regulations of the state and the university. For more information, please pay close attention to the latest notice released at http://www.isd.pku.edu.cn.

Visa, medical insurance and accommodation

1) Visa

Students admitted to PKU may apply for a visa at the Chinese Embassy/Consulate in your country with the letter of admission and the JW201/202 form. International students who will study in China for over 6 months are required to obtain an 'X1' visa, which will only be valid for 30 days upon arrival in China. You must come to the International Students Division and apply for a Residence Permit within 30 days in order to obtain a legal status in China.

2) Medical Insurance

The Ministry of Education of China stipulates that all international students must be medically insured throughout their entire planned period of study. Students are required to purchase the Comprehensive Insurance Plan of Foreign Students on the day of registration. Students who do not have valid medical insurance will not be allowed to register.

3) Accommodation

Accommodation will be provided to students with scholarships that cover accommodation. Self-funded students may find their own living accommodation on campus or off campus. Please note that students who live off campus must register with the local police station within 24 hours of arrival.

Degree

Students are required to complete the curriculum, fulfill the designated credits, complete the master's thesis and defend it in front of a panel of experts. Successful graduates will receive a graduation certificate along with the Master's degree, according to the regulation of the Degree Committee.
